- From Route 83 North or South: Exit at Roosevelt/Butterfield Road East. Follow signs to Drury Lane.
- From Roosevelt Road (RT. 38) East or West: Exit Rt. 83 South & to Roosevelt/Butterfield Rd. East exit & follow signs to Drury Lane.
- From West on I88: Exit at Midwest Rd., turn right to Butterfield Rd., turn right to Drury Lane exit.
- From I-294 and I-290: Take I-88 West, exit at Cermak Rd./Spring Rd. Proceed through stoplight, stay on Spring Rd. Drury Lane is on left at the end of Spring Rd
